## DOES "PERSONAL INFORMATION" INCLUDE AGGREGATE OR DE-IDENTIFIED INFORMATION?

No.

By its terms, the definition of personal information excludes aggregated or de-identified information. Specifically, pursuant to an amendment enacted by the California legislature in late 2019, the definition of personal information was modified to state that "[p]ersonal information' does not include consumer information that is deidentified or aggregate consumer information."<sup>1</sup>
