Luke Mines and Chris Beaumont-McQuillan also joined the firm's growing Corporate Real Estate and Funds team in London.

These moves continue BCLP's emphasis on building around strategic 'multipliers' who can leverage the firm's global platform with multi-office, multi-disciplinary practices to serve its international client base.
